IMPORTANT STOP RIDE / STOP SALE NOTICE! Stop selling and riding affected vehicles immediately.

SUBJECT: SNOWMOBILE FUEL TANK PURPOSE

Polaris is issuing a Stop Sale notice for affected Model Year 2021-2023 MATRYX, 2015-2022 AXYS, and select Model Year 2013-2014 Trail Performance (Pro-Ride) snowmobiles.

Polaris has determined that with degraded fuel, and especially after extended storage, some snowmobiles may pose a risk of fire due to electrostatic discharge (ESD) inside the fuel tank. Under specific conditions, vapors may be ignited inside the fuel tank, posing a potential injury hazard.

If a rider needs to start their snowmobile, they must make sure the fuel tank is full and, if it is not, then they need to add fresh gasoline to fill the tank. Polaris is currently evaluating a repair procedure for this concern and will provide an update to dealers in the coming weeks.
